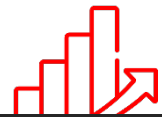

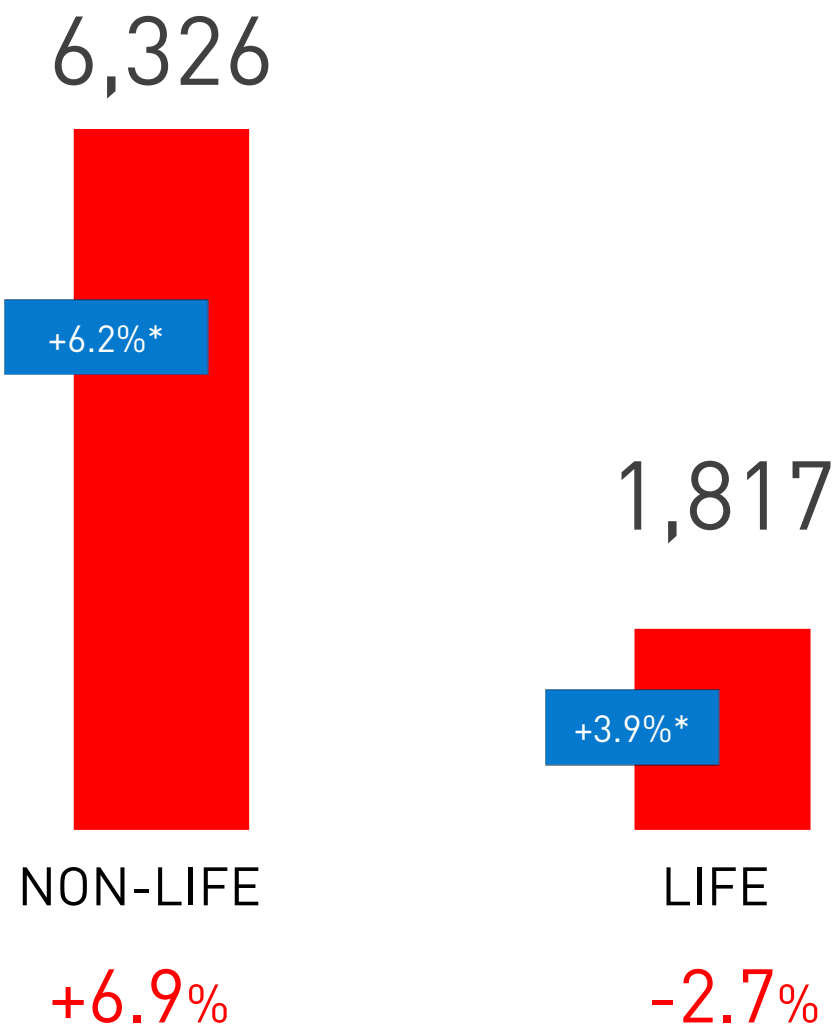

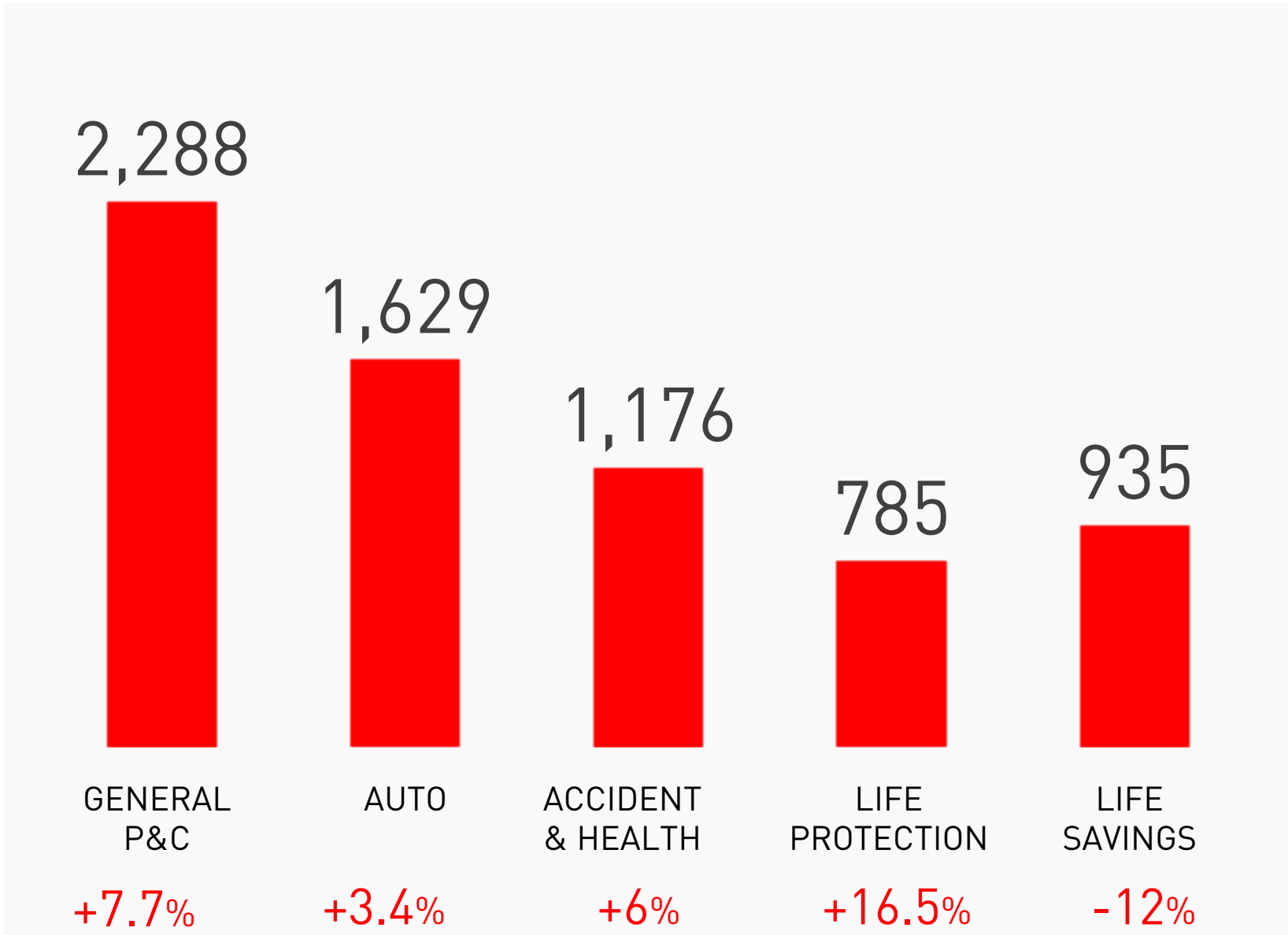

MAIN BUSINESS LINES

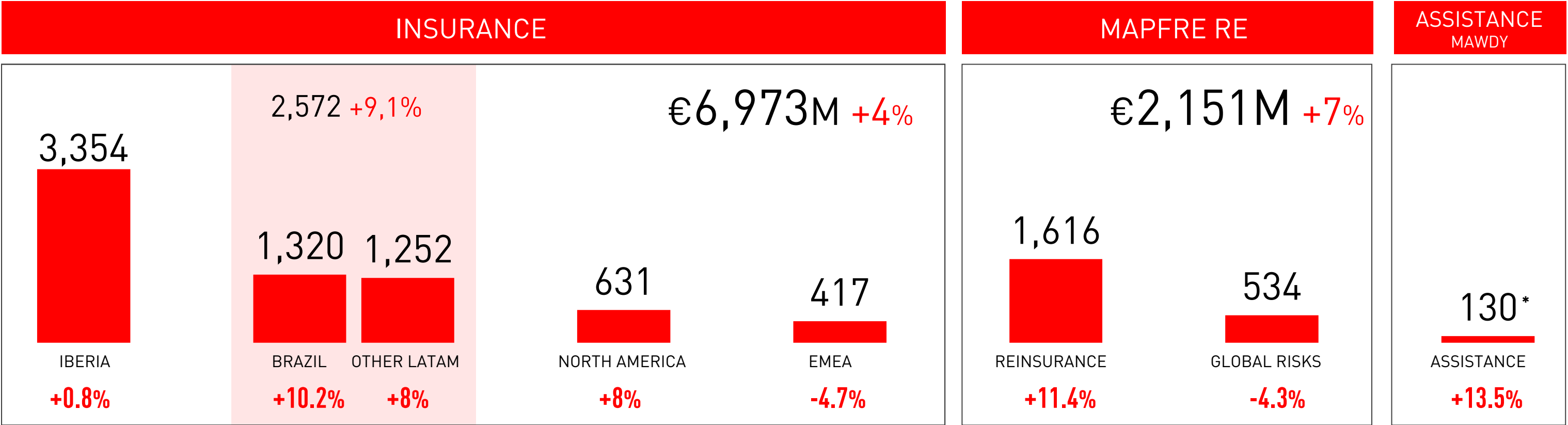

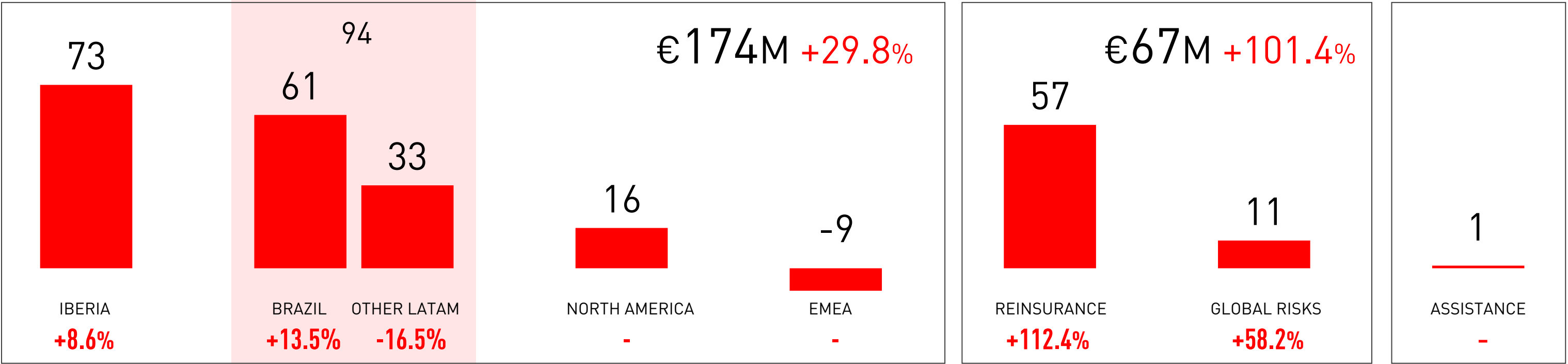
PREMIUMS AND RESULTS BY BUSINESS UNIT
